As per ARKANSAS STATE USBC BYLAWS / Article V & Article VI

A candidate for the board (elected or appointed) must be:

1. a. Adult. A USBC member in good standing at the time of election and throughout their term.
b. Youth. USBC youth members bowling in USBC Leagues within the association’s jurisdiction. Individuals eighteen (18) years old and over must be compliant with RVP requirements prior to working with youth or within 45 days of the start of their term, whichever occurs first and throughout their term.

2. Elected or appointed without regard to race, color, religion, sex, sexual orientation, disability, national origin, or age, other than the minimum age of 14, unless state laws mandate a specific age, and be reasonably representative of the members. a. Any member of the board authorized to sign contracts or act as a signatory on association accounts must be a minimum age of 18. b. A maximum of three bowling center proprietors may serve on the board at one time. A proprietor is an individual who is the owner, partner, or corporate officer of a bowling center or group of bowling centers. Excluded from the definition of proprietor is an individual who owns 25% or less of the equity shares, or who is inactive in the management of the bowling center and remains so during a term as an officer or director.

ADDITIONAL ELIGIBILITY REQUIREMENTS:

1. Officers-Eligibility-Requirements: Article VI Section B

- A. Must have served as a state director or association manager for a minimum of 3 years. A term as an officer cannot be concurrent with the position of State Association Manager.
- B. Must be a member of the Arkansas State USBC Association.
- C. No more than 1 officer from the same Local USBC Association may serve at the same time.
- D. Candidate must become a Registered Volunteer if elected.

Qualifications must be submitted, in writing, at least 24 hours, or up to seven (7) days as determined by the delegates, prior to the annual meeting. Qualifications are due **7 days prior** to the opening of the annual meeting.

2. Director-Eligibility-Requirements: Article V Section B

- A. Candidate may only seek nomination from the association where they obtain their USBC membership. No more than 2 adult directors from the same Local USBC Association may serve at the same time.
- B. If elected director submits their USBC membership in another association outside the association they were elected and their new association already has 2 directors serving, they may continue to serve the remainder of their term in the association they were elected.
- C. Candidate must become a Registered Volunteer if elected.
- D. Must be a member of the Arkansas State USBC Association

3. Director 9, 10, 11 – Any Local USBC Association in Arkansas

- A. Director 9,10,11 candidates must have served either as a youth league supervisor/official, local Youth Director or served on a local or state youth.
- B. No more than one (1) Director 9, 10, 11 from the same Local USBC Association may serve at the same time.
- C. Must be a member of the Arkansas State USBC Association.
- D. Candidate must become a Registered Volunteer if elected.

4. Definition of Local USBC Association

Association where a USBC membership is obtained.

The ASUSBC State Delegate Meeting will be held on June 15 at the Brewer-Hegeman Conference Center on the campus of University of Central Arkansas in Conway, Arkansas. Business meeting will start at approximately 1:00pm. Attendance at the meeting is highly encouraged, but not required for election.
