## **Tournament rules**

USBC Rules and regulation will govern this tournament.

- 1. The purpose of the 44th Annual Women's Senior Singles Tournament is to qualify (an) AR State Senior Champion in each age classification to enter the USBC 2026 National Senior Tournament. The entry fee for the USBC 2026 National Senior Tournament for each age classification will be paid by the ASUSBC out of the tournament expenses. This tournament is certified by USBC.
- 2. The ASUSBC representative will be determined by the highest six game (total pin fall, plus handicap), in each classification. If the first-place winner is unable to bowl in the National Senior Tournament, alternate selections will be made in order of finish, up to and including fourth place. In case of a tie for first place, the first three games bowled, with handicap, will be used to determine the winner. Prize money for ties will be combined and divided equally. USBC Rule 326A.
- 3. Entrants must be members in good standing in their local, ASUSBC and USBC and must have current 2025-26 membership card. Affiliate membership cards and/or participation fees are not available. No professional bowlers allowed. Employees of the hosting bowling center shall be eligible to participate in the tournament.
- 4. **All entrants must be at least 50 years of age by July 1, 2026**. Age as of date of bowling will determine the classification in which the bowler must participate. Proof of age, other than entry form may be required.
- 5. The tournament will consist of six game event bowled on the same pair of lanes. Participants may enter only one time. No entry fee will be refunded except when ASUSBC notifies an entrant of date and time assigned and the ASUSBC tournament director has received refusal of the date and time within 14 days of the schedule notice.
  - **A.** Entrants shall use their highest 2024-25 ASUSBC average whether bowled as a regular bowler or substitute. (A bowler with membership in more than one state shall use her highest 2024-25 average. Verification from the out of state local association manager must be attached to the entry form).
  - **B.** If "A" does not apply the highest summer league average established in a certified league, which started their schedule after March 15 for the 2025 summer session, shall be accepted provided 21 games have been bowled. Proof of average signed by the league secretary or association manager must be attached.
  - **C.** If no previous average or summer league average, entrant shall use their highest current average at time of bowling provided 21 games have been bowled. This average must be verified by either league secretary or association manager and proved to the tournament director prior to time of bowling.
  - **D.** Rule 319a shall not apply when reporting averages (rule states in part: failure to use proper average or make a correction prior to completion of the first game of a series shall disqualify score if submitted average is lower than actual average or prize winning will be based on submitted average if higher). USBC Rule 319a (10 pin rule) shall be waived.
- 6. Handicap will be 90% of the difference between the entrant's entering average and 230.
- 7. Entry fees shall be paid by check or money order made payable to the Arkansas State USBC Association. CASH WILL NOT BE ACCEPTED. Venmo payments will be accepted with a 2% fee. There will be a \$25 returned check fee that must be paid before you will be allowed to bowl.
- 8. Cash prizes will be awarded on handicap basis, at least one for every five entries. An entry to the USBC 2026 National Senior Tournament will be presented to the first place winner in each age group on handicap basis. Prize fee will be returned 100%.
- 9. A bowler arriving late may begin play with the score to count from the frame being bowled (USBC rule 322a-1b) No score will be given for frames missed.
- 10. In the event a bowler cannot finish their series, zero pins will be scored for the remaining frames.
- 11. Neither substitutes nor pacers will be permitted.
- 12. Any claims for errors in scoring or calculations must be filed with a tournament official no later than twenty-four hours after the completion of the six games.
- 13. Any protest must comply with USBC rule 329.
- 14. Check-in will begin one hour before scheduled squad time and entrants may be asked to present their USBC membership cards. Bowlers will receive 10 minutes of practice before scoring begins.
- 15. Checks in payment of money prizes won will be mailed within thirty days after the close of the tournament, except when the USBC has authorized delay in payments.
- 16. If your check is returned all entry and other fees must be paid in cash before the bowler will be allowed to compete.
