* 7-game block—Total Pins determines place and carry over to Semi-Finals

* 1:3 will advance in each division and will CASH - Will also pay High Senior Male/Female non advancer

Semi-Finals / Finals: Sunday, November 9, 2025 - within 30 minutes after Qualifying

* All Advancers will bowl 3 games. Top 4 will advance to stair step finals in each division immediately following Semi Finals

TOURNAMENT RULES

The ASUSBC Masters & Queens Tournament is an individual competition based on total pin fall and is conducted on a scratch basis. This tournament is open to Male, Female and Youth USBC members in good standing with a 2025-26 Membership. Collegiate bowlers with a 2025-26 USBC Membership eligible to bowl. PWBA/PBA card holders will be allowed to compete. Any PBA/PWBA—Regional or National title holders in the last 2 seasons will not be allowed to enter. Youth are eligible to bowl with prize money going into their SMART account.

LIMITED TO FIRST 90 PAID ENTRIES —60 MEN / 30 WOMEN

1. Entry Fee \$150.00. (Prize Fund \$100.00, Lineage \$45.00, Expense Fee \$5.00). Prize fund returned 100%.
If paid via VENMO to Arkansas State USBC, the fee is \$155.00.
2. Check in will begin at 9:00am. Practice will begin at 9:50am, scoring at 10:00am.
3. If a bowler is not present at the scheduled competition time, an alternate bowler will be given the opportunity to bowl. A waiting list will be set up once the tournament is full. Should the tournament not receive 18 women's entries, the spots will open to any additional bowlers on the waiting list for the Masters division. NO SHOWS will not be refunded.
4. Lane Assignments and Rotation - Will be random draw by Tournamentbowl.com Program. Bowlers will move after each game as indicated on the recap sheet for each bowler. Semi-Final lane assignments will be provided upon confirmation of qualifying scores and advancers.
5. Semi Final Advancers and pay ratios will be 1:3 men and 1:3 women. Will also pay the high Senior out of the cash in both divisions. The top 4, 10 game total pinfall, from each division will compete in a stair step final bowled on pairs not in play for semifinals. One pair designated for men and one pair for the women.
6. If there is a tie in qualifying, semi-finals or finals, 9th & 10th frames will be bowled. Total pins will determine winner.
7. A sport pattern will be used in competition and will be announced prior to the tournament on our Facebook Page, Arkansas State USBC, and our website, www.arkansasstateusbc.com.
8. **Dress Code: Proper dress code will be followed, please see www.arkansasstateusbc.com.**
9. An entrant may be disqualified for the following during the tournament:
 - A. An infraction of the rules
 - B. Conduct derogatory to the best interest of the tournament.
 - C. Use of foreign substance which comes in contact with the approachAny infraction of the rules will be cause of immediate disqualification and removal from the tournament.
Disqualification will result in forfeiture of entry fee and prize money.
10. Tournament Staff shall have the authority to decide any matters pertaining to the operation of this event not addressed in above rules. All decisions of Tournament Staff are final unless an appeal is made in accordance with USBC rule 329.
11. Any rules not covered above, USBC rules will prevail. Protests concerning scores while the game is in progress shall be reported to Tournament Staff immediately and play shall cease until determination is made. The ASUSBC Board of Directors shall have the power to hear and act on all protests arising from or under construction of these rules.
12. Brackets and other side action will be available only to **ADULT** participants. CASH ONLY for brackets and side action.
